## BANK JATIM & BPR JATIM SIGN MOU OF DISTRIBUTING CREDIT TO FINANCIAL INSTITUTION (KKLK)

Surabaya, 13 July 2015 – as financial institution of East Java society, PT Bank Pembangunan Daerah Jawa Timur Tbk **(bankjatim)** and BPR Jatim are demanded to contribute more in developing region.
